HEREBY STATES:

- to have read the *Federation's Protocol*, their *Guidelines* and the *Guidelines for players and hosting Clubs* to contrast and reduce the risk of COVID19 infections while playing Golf;
- to have read the PGAI teaching protocol;
- to have read the protocol used by the hosting Club;
- to have read the Safety Protocol for the COVID19 pandemic emergency;
- to have had my/the underage athlete's temperature taken before accessing the practice site and that the temperature was not above 37.5°C;
- to have never been in close contact with anyone affected by Coronavirus COVID-19;
- to have not received any communication from the authorities regarding a close contact with a person affected by Coronavirus COVID-19;



- the athlete is not currently undergoing quarantine or self-quarantine with health authorities surveillance, as foreseen by the law currently into force;
- the athlete has not had any symptoms that could be linked to infection from Coronavirus COVID-19 in the last 15 days, among which:
 - *Temperature above 37.5°C;*
 - *Cough, asthenia, difficulty to breathe, headache, diarrhoea, loss of sense of smell (anosmia), loss of sense of taste (ageusia);*
- to have had a negative rapid nasal swab (antigenic) or higher level test (e.g. RT-PCR) within 72 hours from arriving to the competition site or certify that they have been immunized by vaccination (i.e. that they have received both planned doses).

AND SHALL:

- respect all the Federation's Protocols and Guidelines and the Protocol used by the Club hosting the sport event;
- respect all general prevention and safety measures established by the relevant Authorities, maintain social distance and use the personal protective equipment as foreseen by the Federation's Protocol, hosting Club and relevant Authorities;
- continue respecting all general prevention and safety measures established by the relevant Authorities also when not involved in the federation's activities;
- in case of symptoms appearing while on the training course, respect and follow all prescriptions foreseen for this matter in the Safety Protocol for COVID19 pandemic emergency;

We hereby acknowledge that all personal and particular data - collected through this statement or that may be collected after measuring the temperature before entering into the Club hosting the event - shall be processed in compliance with EU Regulation n. 2016/679 (General Data Protection Regulation) for the purpose indicated in the report submitted as foreseen by article 13 of the aforementioned regulation.
