INFORMATION

Pursuant to articles 13 and 14 of EU Regulation 2016/679 (hereinafter “GDPR”)

Dear Sir or Madam,

As foreseen by article 13 of the GDPR, we hereby inform you that the **Italian Golf Federation** (hereinafter “Federation”) - Data Controller – shall process for the purpose indicated here below your personal data you gave us on behalf of the Athlete competing in this event at the moment of your “Statement regarding prevention of Covid-19 infection”.

In particular, the Federation shall process the following personal data:

- a) The parent’s or Team Manager personal and identification data (name and surname, date and place of birth, sex, tax number, address, State of birth and nationality, phone number and e-mail);

Moreover, we hereby inform you that the Italian Golf Federation will process the aforementioned athlete’s personal and particular data submitted and acquired during the registration phase for the competition above.

In particular, the Federation shall process the following personal and particular data:

- A) Personal data;
- B) Data useful to establish the health condition indicated in the statement regarding prevention for covid-19 infection you have duly signed.

1. Legal basis and purpose of the processing.

This processing is required to prevent infections from COVID19, in compliance with the DPCMs (Decrees of the Italian Prime Minister) issued for urgent measures to contain and manage the COVID-19 pandemic emergency, the Protocol approved by both the Italian Government and the Unions on 14/3/2020, updated on 24/4/2020 and other measures as well as the Federal Protocol and Guidelines to contrast and reduce the risks of COVID-19 contagions while playing Golf.

2. Processing methods

The processing is made by the Federation’s personnel also via electronic means as indicated in article 4 n. 2) of the GDPR, i.e.: the processing of personal data may foresee data collection, registration, organisation, view, processing, amendment, selection, extraction, comparison, use, interconnection, blocking, communication, erasure and destruction.

3. Mandatory nature of the provision

Data provision for the purposes indicated above is compulsory to fill-in the “Statement regarding prevention of Covid-19 infection” necessary for the Athlete to participate to the sport event indicated in the title.

Refusal to supply the data above shall make your enrolment in the sport event impossible.

4. Data recipients

The personal data above shall be processed by the Federation’s personnel, duly authorised in compliance with article 29 of the GDPR and shall not be communicated to third parties but for the cases foreseen by the law.

5. Transfer of data abroad

The Federation shall not communicate any personal data.

6. Data retention period

Your data will be stored for the time required to achieve the goals for which they have been collected, in compliance with specific law provisions and, however, until the end of the emergency linked to the COVID19 pandemic.

8. Data Protection Officer

9. Rights of the subject concerned

You have the right to know about your data at any time; know how they have been obtained, verify they are correct, complete, updated and well stored, ask their rectification or erasure, in compliance with articles 16 and 17 of the GDPR. Moreover, you have the right to receive the data obtained from you and processed following your consent in a structured and commonly used format, readable by any automated device and to withdraw your consent to their processing.

As foreseen by article 21 of the GDPR, you have the right to oppose the processing of part or all data for reasons linked to your particular situation. These rights can be exercised via specific appeal – also, if you wish, by using the form issued by the Italian data protection Authority, which you can download from www.garanteprivacy.it – to be sent via registered letter or email to the data controller. You also have the right to file a complaint to the Italian data protection Authority.
